We have secured preferred rates at our area hotels and it is required to contact our Official Travel Liaison, Dick Doherty @ Crystal Lake Travel (Ph: 815-459-2500) to handle your arrangements and special needs. He is very experienced with CABA and his firm is awesome to work with.

Each year we reserve tickets and luxury buses for a Major League Baseball game. A Cubs game has been our most requested event from past World Series evaluations and the feature game for 2006 is the Chicago Cubs vs the Arizona DiamondBacks @ Historic Wrigley Field. We have secured nearly 1500 tickets and 30 buses for this game which is on Tuesday, Aug. 1st. All buses will leave from our flagship hotel, the Crystal Lake Holiday Inn, at 3:00pm sharp for the 7:05pm game. Buses will return immediately after the game to the CL Holiday Inn.

We have invested nearly \$40,000 in tickets and nearly \$15,000 in reserving luxury buses. The event is open to all CABA players, coaches, families and fans on a first come, first served basis prior to going on sale to the general public.

All Cubs night games are sell-outs and parking around the Wrigley neighborhood is quite expensive. We are requesting that each team expedite to the Executive Director as soon as possible the total Cubs tickets requested and the amount due. Tickets are \$55 per person. It will be a sensational experience for all!

This will be our 14th consecutive year of hosting the CABA Ultimate World Series Events and we are quite proud of the numerous international accolades that have been bestowed upon us.
